

# Minutes of the Elko County Library Board

August 20, 2013

**Date, Time,  
and Place**

The meeting was called to order on Tuesday, August 20, 2013 at 4:02 pm in the meeting room of the Elko County Library with President Lynne Volpi presiding.

**Orr motioned to approve the July 2013 minutes with a second by Minter. Unanimous, Volpi voted aye. Motion carried.**

**Claims**

**McClure-Porter motioned to approve the claims from 7/23, 8/6, and 8/20/13 with a second by Diedrichsen. Unanimous, Volpi voted aye. Motion carried.**

**Operating  
Report**

Hammons reported:

- **Morgan Stanley**

Hammons apprised the Board that Ally Bank did not offer services to businesses so the motion from the July meeting could not be carried out. She provided the current interest rates for the local financial institutions explaining that she called US Bank online for their rates and was informed that we had to work with our local branch for the business rates. The Elko Federal Credit Union offered the best option for a Savings account after all the requirements and fees were accounted for. The monies would make about \$52 a year. US Bank offered the best interest rates for CDs (19 months/.50%; 37 months/.75%; 59 months/1.5%). Hammons recommended the 19 month option so the Board could take advantage of higher interest rates at the end of the 19 months.

**Diedrichsen motioned to place all of the \$38,622.90 currently at Morgan Stanley in a 19 month CD with a .50% interest rate, with US Bank ., A second was made by Orr. Unanimous, Volpi voted aye. Motion carried.**

- ✓ Hammons presented a summary for Fiscal Year 2013 End of Year Report. The Board would like some comparisons from past years as well as other libraries in the state for next month's meeting.
- ✓ LSTA Grant cycle begins at the end of the month
- ✓ Hammons and one Board member will definitely not make the October Board meeting. It was agreed that the regular date will be kept with Assistant Library Director Kassie Antonucci providing information for the Board in the absence of Hammons.
- ✓ The Nevada State link [www.greenzonenetwork.org](http://www.greenzonenetwork.org) that is specifically for Veterans has been added to the library's website.
- ✓ Hammons has initiated the process to get LibraryAware, a service that will allow trained staff to create more professional looking marketing items for the library.
- ✓ Hammons is researching "Geek the Library" an awareness campaign. She stated that the Board will have to assist with this as staff and Board attend area events to promote the library. It cannot just be done with library staff.
